In case of personal changes after present deadline (30 days before the start of the fair), the Exhibitor will have to pay for each passes.
 Such passes are charged for in accordance with the schedule of prices.

- The Exhibitor may enter the area of the Fair upon the presentation of „EXHIBITOR” identification cards.
- The Exhibitor is entitled to receive identification cards depending on the size of the rented area:
 - up to 10 sq. m - 2 identification cards, - up to 50 sq. m - 4 identification cards, - up to 100 sq. m - 8 identification cards, - more than 150 sq. m - 12 identification cards.
 - up to 20 sq. m - 3 identification cards, - up to 75 sq. m - 6 identification cards, - up to 150 sq. m - 10 identification cards,
- Each Co-Exhibitor receives two „EXHIBITOR” identification cards no matter what the size of rented area is. The Exhibitor may also purchase extra „EXHIBITOR” identification cards.
- During construction and dismantling of stands the Exhibitor may enter the exhibition area upon presentation of „SERVICE” identification cards.
- Cars may enter the fair area during an event upon presentation of a payable car park card. Each Exhibitor and Co-exhibitor receive one car park card free of charge. Extra cards may be purchased (form no 5).
