# The Chainalysis 2023 Geography of Cryptocurrency Report

# **Comprehensive Insights into Regional Patterns of Crypto Adoption**

Paris, November 14, 2023 - Chainalysis, the blockchain data platform, is announcing the publication of the fourth annual <u>Chainalysis 2023 Geography of Cryptocurrency Report</u>, with its centerpiece, the <u>2023 Global Crypto Adoption Index</u>, which is composed of on-chain and web data to measure which countries are leading the world in grassroots crypto adoption.

The purpose of the index is to assess which global markets have the highest grassroots adoption. Chainalysis employs a blend of its proprietary on-chain data and third party data to determine which countries are at the forefront of this movement. Unlike focusing solely on countries with the highest transaction volumes – typically the largest and most affluent nations – the index spotlights the places where everyday individuals are most enthusiastically embracing cryptocurrencies for everyday use. To achieve this, Chainalysis developed the Global Crypto Adoption Index, which identifies countries where a significant portion of the population is actively investing a substantial portion of their wealth in cryptocurrency.

# **Key highlights**

- The ranking of the top 20 countries in terms of grassroots crypto adoption is determined by evaluating five sub-indexes, with adjustments made based on purchasing power parity per capita.
- The Central & Southern Asia and Oceania (CSAO) region takes a prominent position at the summit of the index, with six out of the top ten countries hailing from this region.
   Several distinct factors underlie each country's ranking. A more in-depth exploration of this region delves into:
  - The gaming-driven crypto economy in the Philippines
  - The popularity of stablecoins amid rapid inflation in Pakistan
  - India's booming crypto economy despite a challenging regulatory and tax environment
- Lower middle income (LMI) countries have seen the greatest recovery in grassroots crypto adoption over the last year.

Institutions across Central, Northern, and Western Europe are expanding their horizons through experimentation with DeFi and Web3



Central, Northern, & Western Europe (CNWE) is the second-largest cryptocurrency economy in the world this year, behind only North America. The region accounted for 17.6% of global transaction volume between July 2022 and June 2023, and received an estimated \$1 trillion in on-chain value during the same time period.

Throughout the area, decentralized finance (DeFi) stands as the most favored service category, representing 54.8% of the received cryptocurrency value. DeFi has been a pivotal element in driving crypto adoption in CNWE over recent years, particularly through the proliferation of decentralized exchanges (DEXes). Although much of this engagement was spurred by retail participants, institutions across the region are increasingly embracing DeFi, encouraged by regulatory structures that endorse a variety of web3 ventures.

Six of the 50 biggest grassroot adopters of cryptocurrency according to the Global Crypto Adoption Index are based in CNWE: the United Kingdom (14), Spain (22), France (23), Germany (26), Italy (37), and the Netherlands (39).

Known as our line of Michigan made handguards, stocks, buffer tubes, and more, UTG PRO® brings to the market a classic improvement for the iconic MP5 with a unique monolithic handguard. The UTG PRO® MP5 monolithic M-LOK® handguard combines M-LOK® and optics real estate into one rigid and slim drop-in mount.

Precision CNC machined from 6061-T6 aluminum and with an overall installed weight of only 9.6 ounces, the handguard is finished in H-146 graphite black Cerakote® in replace of a matte black anodize. A decision we made in efforts to better match the painted finish found on MP5 receivers. Our patented claw mount locking interface utilizes four proprietary lugs that are inserted from the sides and through the upper monolithic portion of the handguard where four vertically installed T10 screws securely clamp the lugs against the receiver.

The handguard, which practically spans the length of the MP5's sight radius, provides an extended 16-slot Picatinny top rail that begins just forward of the rear sight drum and ends just before the charging handle recess notch. A cutout in the rail allows for positive identification of the serial number. Speaking of the recess notch, the part of the handguard that overlaps the notch is chamfered to specifically prevent hot spots or snag points from happening when manipulating the charging handle with or without gloves. In addition to the chamfer, access to the charging handle remains quick and effortless and shooters will have no worry about tearing up their fingers or knuckles as the top of the handguard transitions from Picatinny to M-LOK® the remainder of the way to the front sight.

Around the circumference of the handguard are a total of 17 full and 5 half M-LOK® slots. In addition, two integral anti-rotational QD sockets are featured and are located toward the front of the handguard at the 3 and 9 O'clock positions. The multiple M-LOK® positions make quick work of installing lights, lasers, foregrips, and more onto the receiver of the MP5. A task that is somewhat of a conundrum for the classical MP5 compared to more modern offerings. The UTG PRO® MP5 monolithic handguard is designed for the 9mm receiver MP5 and clones and is compatible with most, if not all, collapsible and fixed stocks.
